### GENERAL SALES CONDITIONS

The sale of products and services by Phono Press International Srl (hereinafter named "Company") to Buyer is regulated in accordance to these General Sales Conditions; every modification or exception to them must be have a mandatory written form and must have been pre-authorized by written by Company.

- 1) Transportation and delivery of goods. Goods are always travelling at Customer's risk, even if agreed shipping is DAP (Delivered at place). Company will therefore not respond in any dispute arising - even with third parties - concerning a missing, partial or delayed delivery of goods.
- 2) Payment forms / delayed payments. Goods are property of Company until they are not fully paid by customer. Only payments done directly to Company (without third people or parties involved) are recognized by Company. Unless explicitly stated by the Company by written, (e.g. in the Deliverydocument or in the Invoice), goods must be entirely paid before being shipped to Customer or picked up by him. Incoming payments exceeding the dates due (this means the dates of payment arising from a specific agreement between Company and Seller, normally written in the Deliverydocument or in the Invoice, will give Company the right to charge Customer with legal interests, according to D.Lgs. n. 232 del 9 Ottobre 2002 of the Italian "Codice Civile", calculated from the day after the "dates due" date reported in the Invoice.
- 3) Copyright. Customer, along with the master(s) and artwork, has to fill, date and sign the "Copyright Declaration Form": one per each submitted job. Company reserves the right to wait for this document and inspect it before starting to produce the job.
- 4) Withheld of records in case of disputes regarding Copyright. Company reserves the right to withhold some or all records manufactured for Customer - even if pre-paid - in case of written notices received from SIAE, BIEM organisations or third parties concerning the content of those records and particularly Copyright infringement.
- 5) Quality Standards / Faulty Records. Company adopts a strict QC process either on finished products and on in the procedures which are involved in their physical creation. Thus, if some records of a stock are not fulfilling the expected standards or specification, Company, after having received them back with a proper Deliverydocument, will double check them and replace them with no further expenses for Customer or, alternatively, reimburse their price to Customer. Regarding this matter, Company won't consider requests for replacements or reimburses regarding:
  - a) The records playback "timbre" (because, once that grooves have been correctly cut, the playback timbre depends almost exclusively on the playback cartridge and stylus);
  - b) The color tints of labels and covers, the type of used paper, the finishing, the die-cutting and the glueing of the covers, unless Customer has not previously ordered, paid and accepted one or more "Cromalin"(s) which in this case will be used as comparison;
  - c) dips, little surface imperfections, little spots on the surface of records, if they don't have an audible impact on sound;
  - d) slight weight differences between records or a single stock.
- 6) Property of metalparts. Since the complete metalwork, this means the cutting, the silvering of the lacquers, the nickel electroforming of the copies of the lacquers and of their negatives, is fully invoiced to Customer as a service but also as a tangible "good", even if it doesn't effectively produce a Customer Good as generally it is intended, Customer may ask to receive, along with the records, also the "nickel mothers", this means the nickel copies of the original lacquercuts, for future reference and/or usage. Please note that they are the only piece needed to repress the record in the future if that's will be the case. If he doesn't, Company will hold them in its premises for a maximum period of 2 (two) years since the data of 1st order and then will be free to destroy or recycle/them.
- 7) Privacy. Please read the specific "Privacy" section of this website.
- 8) Jurisdiction. For all disputes arising from these General Sales Conditions, the binding jurisdiction is the Italian jurisdiction, Tribunale di Padova.
